# MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MoU) is being made and executed on this 8th November of 2022

## Between

Maharshi Panini Sanskrit Evam Vedic Vishwavidyalaya (MPSVV) was established in the year 2008 by the government of Madhya Pradesh. The sole motto of its existence was the expansion and propagation of Sanskrit language and literature. Its main objective is to rejuvenate, cherish and disseminate the universal values, knowledge and wisdom presented in Sanskrit language and literature. (Hereinafter referred as MPSVV) represented herein by its nominees, successors and permitted substitutes or permitted assigns; hereinafter referred to as the First Party

## AND

Baraudi Sanskriti Sanskrit Sanskar Shiksha Samiti, having its registered office at Village Barodi, Distt. Datia (Madhya Pradesh), Registered under Madhya Pradesh society registrikan adhiniyam 1973(44). And the organization is also registrede in NITI Ayog Govt. of india.

## WHEREAS

The First Party is a Maharshi Panini Sanskrit Evam Vedic Vishwavidyalaya (MPSVV) was established in the year 2008 by the government of Madhya Pradesh and it offers study programs, courses and conducts research in the range of academic fields covering Language, linguistics, translation and literature, Darshana and Shastra, Vedanta, Jyotishya, Yoga, Manuscriptology, Traditional studies, Ancient Indian studies, Vedic studies, Education, etc.

## WHEREAS

The Second Party, is a Non-Governmental Organization registered as a Madhya Pradesh society registrikan adhiniyam 1973(44). it prepares and

offers Veda, Vedanga, Yoga Traditional studies and Indian Knowledge systems, Education, Indian Culture and Promotion of Sanskrit etc.

## **WHEREAS**

The First and Second Parties mutually agree that the encouragement and development of cooperation and exchange in all areas of mutual academic interest and technical support is desirable. Both parties, therefore, wish to expand the basis of cooperative educational exchange and have set forth the following Memorandum of Understanding.

### **1. Objectives:**

The goal of this MoU is to foster collaboration, provide opportunity for global experience and to facilitate advancement of knowledge on the basis of reciprocity, best effort, benefit and frequent interactions. Both institutes agree.

- (a) To exchange information on research and educational programmes.
- (b) To exchange information on teaching, learning, material and other literature relevant to their educational and research programmes.
- (c) To arrange joint teaching, training and extension activities and exchange of scholars professors and other staff.
- (d) To jointly organize short-term continuing education programs on topic of mutual interest and to invite each other's faculty to participate therein.
- (e) To jointly propose and engage in research or training programmes sponsored by funding agencies and to invite each other's faculty to participate therein.
- (f) To jointly organise seminars, conferences or workshops on topics of mutual interest and to invite each other's faculty to participate therein.
- (g) To collaborate in cultural, social and co-curricular programmes.



The Parties (MPSVV & Baraudi Sanskriti Sanskrit Sanskar Shiksha Samiti) further agree that detailed terms and conditions that guide each activity identified above will be appropriately determined and agree upon by the two institutions. This term shall include a technical description of the proposed activity, arrangements and persons responsible for its implementation.

## **2. Area of Association:**

This memorandum of understanding is intended to express the broad understanding of the parties hereinto, regarding their association with each other in order to extend mutual benefit.

## **3. Areas of Cooperation:**

The parties shall co-operate in the following areas: -

- (i) Collaboration towards organising joint seminars/conferences/workshops/FDP.
- (ii) Collaboration for joint Research Projects.
- (iii) Collaboration for joint Research Journals.
- (iv) Student exchange programmes.
- (v) Faculty exchange programmes.

## **4. Roles and Responsibilities**

The role and responsibilities will be on case-to-case basis and anything arising out of MOU will be decided on case-to-case basis by both universities.

## **5. Financial Arrangements**

Both parties (MPSVV and Baraudi Sanskriti Sanskrit Sanskar Shiksha Samiti) understand that all financial agreements between the parties have to be further negotiated and mutually agreed and will depend on the availability of funds. Both parties may seek financing of joint activities from internal and external sources available to them.

## 6. General Coordinators

Each institute shall designate an administrative officer to oversee and facilitate the implementation of any agreement arising out of this MOU. These officers are: -

## 7. Intellectual Property

Maharshi Panini Sanskrit University Ujjain and Baraudi Sanskriti Sanskrit Sanskar Shiksha Samiti agree to respect each other's right to intellectual property. Further the Intellectual Property Rights that arise as a result of any collaborative research or activity under this MoU will be worked out on a case-by-case basis and will be consistent with the officially laid down policies of the two institutions.

## 8. Legal Relationships

This MoU shall be construed as a statement of purpose to promote a genuine and mutually beneficial collaboration between the parties. Nothing in this MoU shall create any legal relationship between the parties.

There should be no dispute regarding any aspect of academic cooperation. However, if there is any, The Maharshi Panini Sanskrit and Vedic Vishwavidyalaya, Ujjain and Nirmala College Ujjain will jointly resolve the dispute in spirit of Independence, mutual respect and shared responsibility.

## 9. Commencement Renewal and Termination

This MoU will be effective from the date of the last signature here to and will remain in force for a time period of Three (3) years with a possibility for renewal at the end of the Three-year period, subject to the parties' written agreement. Either party may terminate this MoU by giving three (3) months' notice in writing to the other party.

This MoU has been drawn up in two (2) original copies in the English language, each Party receiving one (1) duly signed copy hereof.
