

## Memorandum of understanding

This Memorandum of Understanding is made on the 30<sup>th</sup> day of September – 2022

Between

Maharshi Panini Sanskrit Evam Vedic Vishwavidyalaya (MPSVV) was established in the year 2008 by the government of Madhya Pradesh. The sole motto of its existence was the expansion and propagation of Sanskrit language and literature. Its main objective is to rejuvenate, cherish and disseminate the universal values, knowledge and wisdom presented in Sanskrit language and literature. (Hereinafter referred as MPSVV).

And

Narmade Ayurvedam (10, Kalidas Marg Maxi Road, Freeganj, Ujjain) & Pragyan Tripathi (M.D. Ayurved).

**This MOU witnesses as under-**

1. Whereas the main objective of the MPSVV is to promote, develop, propagate disseminate and preserve Sanskrit in all its aspects through any accepted mode, including Sanskrit learning under its Non- Formal Sanskrit Education (NFSE) activity.
2. And whereas for implementing its NFSE activity, the MPSVV makes collaborations with the Universities, Colleges, Institutions etc. desirous of promoting Sanskrit learning to its students/staff and general public within its reach, through NFSE Centre along with other similar academic activities at organisation.
3. And whereas, pursuant to the proposal submitted by Narmade Ayurvedam (10, Kalidas Marg Maxi Road, Freeganj, Ujjain) (Principal), for running of NFSE

Centre, the MPSVV intend to collaborate with it for opening of the NFSE Centre in its premises and sign the MOU therefore.

4. And wheresd, the MPSVV will provide the following facilities, arragemests and material for conducting the prescribed course in this NFSE Centre-
  - a. Trained Sanskrit Teacher.
  - b. Prescribed monthly remuneration to be paid by MPSVV. (In addition to his duties in the allotted Centre, he may be required to teach the learners at any other nearby Centre/Centres if required).
  - c. Reading material for the learners
  - d. Prescribed guidelines for NFSE
  - e. Conducting examination at the end of academic session and awading certificate/diploma to the successful candidates.
5. And whereas, the MPSVV will undertake Sanskrit education for certificate Course in Sanskrit Language and Diploma in Sanskrit language of the duration of one year each for the learners in NFSE Centre. Learners enrolled in the Centre will be required to deposit prescribed Registration fee to the MPSVV.
6. And whereas Narmade Ayurvedam (10, Kalidas Marg Maxi Road, Freeganj, Ujjain) will provide the facilities and extend support as under-
  - a. Suitable arrangement for functioning of NFSE Centre, including seating arrangements, infrastructure, electricity etc.
  - b. Nominating a faculty member as authorised officer to coordinate functioning of the Centre. He will be required to ensure that the course are conducted as per the provisions prescribed in the guidelines for NFSE.
  - c. Publicising the Sanskrit learning course of MPSVV in non-formal mode and also making arrangement of the same at its Centre.
7. And whereas in any matter concerning the NFSE Centre or any issue arising in conducting the courses, the same will be resolved jointly by the authorised

offecers of MPSVV and Narmade Ayurvedam (10, Kalidas Marg Maxi Road, Freeganj, Ujjain).

8. This MOU will be valid initially for one academic session and may be extended mutually.

Now, therefore, in witness whereof, this MOU is executed and signed by the officers of MPSVV and Narmade Ayurvedam (10, Kalidas Marg Maxi Road, Freeganj, Ujjain).
