ORDINANCE NO.5

THE CONDITIONS OF THE AWARD OF FELLOWSHIPS AND SCHOLARSHIPS

(Refer Section 35(g) of the Act.)

(For the purpose of this Ordinance, the Act Means Maharshi Panini Sanskrit Evam Vedic Vishwavidyala Adhiniyam 2006 (15 of 2008))

- I. (i) Fellowships, research scholarships and other scholarships may be instituted in the University by the following agencies:-
 - (1) University Grants Commission, New Delhi.
 - (2) M.P.Government.
 - (3) The University.
 - (4) Any government agency.
 - (5) Any private agency or individual, with the prior approval of the Executive Council.
 - (ii) Fellowships/scholarships, thus instituted, can be for undergraduate and post-graduate studies, M.Phil. and Ph.D. degree, post-doctoral studies or for specific academic purpose.
 - (iii) For fellowships/scholarships instituted by any agency, other than the University, the liability of finances shall lie with that agency. The University shall not be liable to make payments, if the funds are not received from the agency.
 - (iv) The value and duration of fellowships/scholarships instituted by the University shall be as laid downbythe Executive Council in consultation with the Academic Council.
- 2. (a) For the fellowships/scholarships, which are lying vacant, and which have to be awarded by the University, the University shall invite applications through an advertisement in the newspapers.
 - (b) All awards of fellowships, research scholarships and other scholarships etc, which are to be awarded by the University shall be made on the recommendation of a committee consisting of
 - (i) The Kulpati Chairman
 - (ii) Three Deans of Faculties appointed by the Kulpati every year.
 - (iii) The Registrar Member-Secretary
- 3. Subject to the general conditions applicable to all fellowships and research scholarships as laid down in paragraphs 4 and 5 below, the value, duration and conditions of award shall be such as laid down by the agency instituting the fellowships/scholarships.

- 4. The award of fellowships and research scholarships shall be made subject to the following conditions:
 - (i) The fellow/scholar will do whole-time research work under an approved guide on a subject approved by the University.
 - (ii) The fellow/scholar shall not accept or hold any appointment paid or otherwise or receive any emolument, salary stipend etc. from any other source during the tenure of the award nor shall he engage himself in any profession or trade during that period. He may, however, undertake teaching assignment of not more than nine hours a week in the institution, where he is working subject to the guidelines attached with the fellowship/scholarship.
 - (iii) The fellow/scholar shall not join any other course of study or appear in any examination after commencing the work under the fellowship/scholarship.
 - Provided that the Kulpati may, on the recommendation of the guide, permit the fellow/scholar tojoin a language diploma course and appear in an examination thereof.
 - (iv) Unless permitted by the guide to work for a specified period at some other place, the fellow/scholar shall be required to attend the institution, where he is to war on all working days.
 - (v) If at any time it should appear to the University that the progress or conduct of the fellow/scholar has not been satisfactory,the fellowship/scholarship may be suspended or withdrawn.
 - (vi) (a) Leave shall be admissible to the fellow/scholar according the rules of the agency instituting the said fellowship/scholarship.
 - (b) For fellowships/scholarships instituted by the University the guideline of the University Grants Commission shall be applicable with regard to leave.
 - (vii) The fellow/scholar shall be required to pay the fees prescribed by the University.
 - (viii) If any information submitted by the fellow/scholar in his application is found to be incorrect, incomplete or misleading the award may be terminated by the Executive Council forth with.
- 5. For undergraduate and post-graduate scholarships instituted by the University:
 - i) Post-graduate scholarships if instituted by the University, shall ordinarily be tenable for two academic sessions, i.e., twelve months in the first year and ten months in the second year on the condition that the scholarship holder produces a certificate of efficiency in studies from the Head of the University Teaching Department or the Principal of the College, where the candidate is studying.

- ii) Undergraduate scholarships, if instituted by the University, shall ordinarily be tenable for three academic sessions, i.e., twelve months in the first year, twelve months in the second year and ten months in third year on the condition that the scholarship holder produces a certificate of efficiency in studies from the Head of the University Teaching Department or the Principal of the College, where the candidate is studying.
- iii) The scholarship shall be tenable from the 1st of July if the scholarship holder joins the institution within one month of the date of the opening of the institution after the summer vacation and pays the tuition fee from the commencement of the session. In any other case, it shall be tenable from the date on which the candidate joins the institution.
- iv) In case of undergraduate/post- graduate scholarships instituted by the University, a scholarship shall be cancelled if the scholarship holder fails to secure at least 50% marks in the examination.
- v) If a scholarship holder is unable to appear at the examination on account of sickness or any other reasonable cause, the scholarship for the months of March and April shall be paid if the Head of the institution certifies that the scholar diligently studied for the examination, but was unable to take the examination for reasons beyond control. Such a scholar shall not receive scholarship during the next session, but shall be entitled to the scholarship during the studies for the next examination, if the scholar passes the earlier examination with the requisite standard.
- vi) A scholarship shall be liable to termination if:
 - (i) the scholarship bolder discontinues studies during the middle of a session; or
 - (ii) the scholarship holder, after he has been given a reasonable opportunity to explain his conduct, is in the opinion of the Executive Council guilty of a breach of para 9 of this Ordinance and if the Executive Council so directs, the scholarship holder shall also be liable to refund the amount of scholarship drawn by him.

The order of termination passed by the Executive Council shall be final.

- 6. The payment of fellowship/scholarship shall be made only on receipt of scholar's receipted bills duly countersigned by the Head of the institution where he studies. No fellowship/scholarship shall be drawn for a month unless the scholarship holder has attended the institution regularly inthat month.
- 7. The drawal of fellowship/scholarship shall be done inaccordance with the procedure, that may be laid down by the University.
- 8. A fellowship/scholarship holder shall not combine any other course of study with the course for which the award is made.
- 9. A scholarship-holder shall at all times be of good behaviour and observe all rules of discipline.
- 10. Incase of any dispute/ambiguity, the decision of the Kulpati shall be final.
